List of Clinics Open for Emergency Care - IMPORTANT

Some chiropodists and podiatrists are unable to continue to provide in person services despite the Government Order which allows them to do so for emergency care. The College is attempting to develop and have available to the public a list of those members who have the ability to continue to provide foot care in an emergency. The College would be pleased to include you on a list of members who are offering to provide emergency care. We would remind you that you cannot do so unless you have appropriate PPE and are maintaining appropriate standards with respect to Infection Prevention and Control, as directed by Public Health Ontario and the Colleges Standard of Infection Prevention and Control.

In addition any office that is offering to provide this service for patients must inform us if the situation changes and the service can no longer be offered, so that the list can be revised. To be included on the list we would need written request to do so as well as your contact information, phone or email, so that prospective patients contact you. The College expects you to make all reasonable efforts to determine if the care required is in the nature of an emergency before offering to provide the patient with an appointment. It also expects you to take all reasonable screening measures to determine the risks involved in treating any patient before permitting the patient to attend at your office.

The College reserves the right to remove your name from the list at any time without prior notification

should it feel that it is necessary to do so.

We would ask that you provide your name, phone number and practice location. Please respond by Monday, April 6, 2020.
