Orthopaedic Footwear Standard – Updated

On October 29, 2021, Council approved updates to the Orthopaedic Footwear Standard. The new standard is available on the College’s website in the list of “Standards of Practice for Chiropodists and Podiatrists”. There are some important changes in the amended standard, and it is the members’ responsibility to ensure they fully understand the standard and ensure they comply with the amendments going forward. Honorarium Policy – Updated

At its October 2021 meeting, Council approved a new honorarium policy for Council and non-Council committee members that replaces the old policy, which had not been updated since 2002. To draft the policy, College staff conducted an environmental scan that looked at the rates other regulatory health colleges pay professional members for College business. The results of the scan indicated that the College’s honoraria rate was significantly lower than other RHPA Colleges. It is in the public interest that the College fairly compensate members of Council and its committees, because without active and engaged professional members, the College cannot fulfill its regulatory mandate of protecting the public....

Bylaw Amendment Update – Fee Increase

In June 2021, Council passed two bylaws in principle that were circulated to the membership for consultation via email. Members were asked to provide feedback by August 29, 2021 about the proposed amendments to the annual renewal fee. The feedback was provided to Council for review.

At its October 29, 2021 meeting, Council voted in favour of amending Bylaw 2 to allow a \$100 increase to the 2022 annual renewal fee, and a subsequent cost-of-living increase annually beginning in 2023. The fee increase acknowledges that costs have gone up since the last fee increase in 2014, and the College requires additional funding to fulfill its mandate of regulating in the public interest. As well, the cost-of-living increase is intended to avoid the need for larger fee increases in the future.



Registration Exam Update

Based on the results of the online written exam in June and the OSCE in August, the College has welcomed 38 new members.

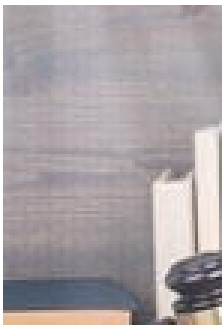
On October 23, 2021, the College's second online written exam of the year took place and we look forward to registering our new members before the end of the year.
